1. PURPOSE (Executive Summary)

To appoint an eligible nominee to fill the Burke Shire Council's vacant Councillor position.

2. BACKGROUND & PREVIOUS COUNCIL CONSIDERATION

Councillor Zachary Duff resigned from his position as Councillor of the Burke Shire Council on Friday 22nd May 2015. This was done through submission of a signed letter of resignation to Philip Keirle, Chief Executive Officer. In accordance with section 162(1)(f) of the Local Government Act 2009, upon receipt of this letter of resignation, the office became vacant.

On 22 May 2015, Council notified the Director General of the Department of Local Government of the vacant Councillor position on the Burke Shire Council.

In accordance with section 166(8)(a)(i-ii) of the Local Government Act 2009, Council advertised the vacant position in a regional newspaper and on Council's website within 14 days of the office becoming vacant and invited eligible nominees to express their interest in the position.

In accordance with section 166(8)(b) of the Local Government Act 2009, Council invited nominations from each person who was a candidate for the office of the former councillor at the last quadrennial election within 14 days of the office becoming vacant.

18 June 2015 was the closing date for the submission of nominations for the vacant Councillor position. By close-of-business on 18 June 2015, Council had received 5 nominations for the vacant office.

Council will consider these nominations and appoint, by resolution, one of the nominees to the vacant Councillor position on Monday 22 June 2015.
