- An alternative name has been put forward for the facility to be called Webber & Clarke Grandstand (Grandstand/Shed/Watering hole) and this involves the Clarke family.
- Given this, it may be perceived that my participation in this decision might lead to a decision that is contrary to the public interest.

Having regard to the nature of this matter, and the nature of my declarable conflict of interest, I consider that I can participate in deciding this matter in the overall public interest.

I, accordingly, wish to participate in the decision in relation to this matter. I acknowledge that eligible councillors must now determine, pursuant to section 150ES of the *Local Government Act 2009*, whether I: -

1. PURPOSE

This report is to confirm the naming of the Burketown Wharf Precinct and Gregory Spectator shed.

2. BACKGROUND & PREVIOUS COUNCIL CONSIDERATION

The Local Government Act 2009 and the Place Names Act 1994 allocate authority or responsibility to a local government for the naming of local government infrastructure assets within its jurisdiction, including roads, bridges, car parks, footpaths, municipal parks, reserves and sports grounds and associated structures and facilities.

Council's naming of Council-controlled Assets Policy (GOV-POL-008) anticipates that Council will seek community input into all asset-naming process, with Council to make the final decision via Council resolution.

Council has a range of assets under its control that are eligible for naming and a number of assets that may be appropriate to re-name given differences between colloquial /formal names.

Assets identified in the Policy included Burketown Wharf Precinct and Gregory Spectator shed.

Naming of Council-controlled assets will be by resolution of Council and will have regard to the Principles outlined below.

Use of alternative naming categories

At the request of the community or elected members, Council may, at is discretion name a previously unnamed asset in accordance with one of the following categories:

- In acknowledgement of the traditional owners of the land, an elder of the traditional owners, or another name that has a strong indigenous connection to the land (these requests must be referred to the relevant Aboriginal authority for comment);
- Suggestive of the geographical/natural features located nearby or flora and fauna endemic or native to the area;
- In recognition of local families who have provided long term, significant, beneficial associations to the area in which the asset is located;
- A service club or community group that has provided significant financial or manual labour assistance towards the acquisition or construction of the asset or otherwise to the community in which the asset is located.
- Early explorers/pioneers/local history;

- Thematic names consistent with the locality; and
- War Casualty/Honors Lists

Language

- Names should be simple, concise and easy to recognise, spell and pronounce. In the case of Indigenous languages, it is accepted that a traditional name which might appear at first to be complex will, over time, become familiar and easy to use within the community.
- Names should be no longer than 50 characters. Locality names should preferably be one word, while feature names should include a generic term (e.g. 'river' or 'bay') to indicate the feature type.
- Only characters from the standard alphabet can be included (i.e. no special characters, diacritical marks or punctuation marks). Possessive apostrophes should be removed (e.g. 'Duffs Sump' not 'Duff's Sump'), but apostrophes that are part of a personal name (e.g. 'O'Connor') can be retained. Hyphens should be replaced by spaces.
- Numbers should be spelled out (e.g. 'Seventeen Seventy' not '1770').
- Names should not begin with 'The', unless there are strong historical reasons for doing so.
- Abbreviations, initials or acronyms are not allowed, except for the use of 'St' for 'Saint'.

Aboriginal and Torres Strait Islander names

- Names from Indigenous languages should be transcribed as accurately as possible to suggest a
 pronunciation as close to the Indigenous form as possible. Names should be local to the area
 and endorsed by the local Indigenous community.
- Alternative names can be used to recognise the Aboriginal or Torres Strait Islander name for a geographic feature where an approved name already exists and a name change is not acceptable. Alternative names are usually shown on maps and signs in brackets after or below the approved name, e.g. Big Woody Island (Tooliewah).
- Dual naming is a management tool that can be used to gradually change the name of a
 geographic feature where an approved name already exists and a sudden change to the
 Aboriginal or Torres Strait Islander name is not possible or acceptable. Dual names consist of two
 parts separated by a forward slash (/) and the order of the parts is to be reviewed at regular
 intervals (e.g. Uluru/Ayers Rock).
- In Queensland, geographical features may be given either a dual name or an alternative name, but not both.
- Localities, suburbs and towns cannot have dual or alternate names.

Discrimination

- Names should not be offensive, racist, derogatory or demeaning.
- individual who meets the criteria as per Annexure A Naming Criteria (People);

Commercial names

 Name that could be construed as advertising or promoting commercial enterprises should not be used.

Personal names

 Naming a place in honour of a person will only occur if the individual meets the criteria outlined in Annexure A. The person commemorated should have contributed significantly to the area (ownership of land in itself is not sufficient). The spelling of the place name should follow the spelling of the personal name from which it is derived.

Qualifying terms

 Cardinal indicators and similar prefixes or suffixes (e.g. 'Upper', 'New', 'East', 'West') should be avoided and more distinctive names used. If the use of such terms cannot be avoided, they should appear as suffixes instead of prefixes (e.g. 'Burketown North' not 'North Burketown').

Duplication

- Locality names must not duplicate or be similar in spelling or sound to other locality names within the country (e.g. 'Coburn,' 'Cockburn').
- Feature names should not be similar in sound or spelling to any similar feature in the surrounding area.
- Check for possible name duplication using the Gazetteer of Australia.

Protected names

 Names should not be words or acronyms protected by state or Commonwealth legislation, without the appropriate Ministerial approval.

Public interest

 Place names are intended to be enduring and should only be changed where there are sound reasons. Long-term benefits to the community must outweigh any private or corporate interests, short-term effects, and the impact on the community in making a change.

Disposal/Removal of Asset

In the event a 'named' asset is damaged, removed or disposed of for any reason, the Council is under no obligation to replace the asset or name another asset in its place.

Naming Criteria (People)

Requests from community members or elected members to name assets after individuals or families are received by Council on a regular basis. In order for a request to be assessed, the applicant must demonstrate that the individual or family to be recognised and the name chosen meets the following criteria:

- The individual or family must be respectable and held in high regard within the community;
- Where applicable, the individual or family must be aware of and supportive of the application.

AND must satisfy one or more of the following requirements:

- 1) Have significant cultural links to the land (i.e. A traditional owner, or elder within the traditional owners' group);
- 2) Be an athlete or sporting professional who was either born in the region or lived some/all/part of their life in the region prior to competing in their sport at a national/international level;
- 3) Be an individual who has excelled in their field of expertise and who has been recognised at a national level or higher;
- 4) Had previously owned or had a long association with the land on where the asset is situated prior to Council acquiring the land;
- 5) Provided significant financial assistance, support and/or contributed towards the construction or acquisition of the asset;

- 6) A current or previous employee of either the Burke Shire Council whose dedication and service to local government is worthy of note;
- 7) A member of the community whose community service, dedication to community organisations or achievements have been significant.
- 3. PROPOSAL

The proposal is to name both the Burketown Wharf Precinct and the Gregory Spectator Facility.

The following naming Proposals have been received after community consultation.

Burketown Wharf Precinct -This is covering the Precinct not individual aspects such as Boat Ramp, Carpark area etc, nor future assets e.g. possible Barbecue area.

Don (Dr.) Bowley OAM

Nomination by Paul Poole and Tex and Lynn Battle

Comments in support are:

Tex and Lynn Battle

- Don (He does not appreciate "Donald") has been Senior Medical Officer of the Mount Isa branch of the RFDS for approximately 20 years and is known and appreciated in the North West for his expertise and dedication. His contribution to the health and well-being of people in our area is immeasurable. Don is also an Associate Professor but elects not to use that title.
- We hope this suggestion receives favourable consideration.

Paul Poole

Paul stated that Dr Don has probably assisted every person in the shire and has made a significant contribution to the shire. He also saved the lives of a number of residents in the shire.

He felt his name is well known across the Gulf.

He advised that Dr Don had put his own funds into the Gregory Health Facility.

He also noted that Dr Don was instrumental in getting a RFDS facility on Bentinck Island.

Paul also stated that the name should also acknowledge the Gangalidda name. Lalala.

Violet Booth Wharf

Nomination by Sue Clarke

Sue's comments are:

Violet (VI) Booth (1938 – 2016) lived all of her life in Burketown.

- As seen from the attached she had a wonderful connection to Burketown.
- One of VI's passions was fishing and to me it seems appropriate that a place that enables fishing has her name.
- I would also like to make mention that as far as I can see there are four places in the Burke Shire named after a person:
 - Leichhardt River Frank Webber Bridge
 - Beamesbrook John Yanner Bridge
 - Football Field Phillip Yanner
 - Gregory Health Clinic Tim O'Leary

• I realize decisions are not made on gender; however, wouldn't it be great to have The Wharf named after a much loved lady?

Lalala Gujurunggi

Nomination by Murrandoo Yanner

This is the original Gangalidda name. Lalala means landing and GuJurunggi covers the area between the boat ramp, pontoon and the wharf.

Gregory Spectator Facility

Sue Clarke has put forward two alternatives: Buffalo Community Hub or Buffalo Picnic Pavilion

Comments in support

- The 'Buffalo Picnic Race Club' was one of the Burke Shire's oldest sporting clubs.
- They held race meetings at Gregory in the early 20th century.
- The community would come together for a number of days of racing, dancing and catching up with neighbours they rarely saw.
- The Buffalo Picnic Race Club is now known as The Gregory Downs Jockey Club who continue the heritage of bush racing.
- The attachments show a photo of club members in 1917.
- Two attachments of newspaper articles are from 1907 and 1909.

Sue Clarke's second alternative

The Bough Shed or The Bough Shed Community Hub

Comments in support

- A bough shed is a shade structure that was seen in many mustering camps and at most rodeos and race meetings of the past.
- A timber frame was covered in branches (boughs) and this proved to be a suitable structure for shade and shelter.
- Often the frame was left and the following year fresh branches were placed over it.
- As the new building is a wonderful shade structure, 'The Bough Shed' would bring a historical and outback spirit to the name.

Comments in support

(my submission is more about acknowledging the efforts of both families listed)

For the name of the Gregory Spectator Facility.

When I think of events at Gregory 2 surnames come to mind – Webber's and Clarke's. If you go to any of the events here you will be sure to see a member/s of these families (from grandparents through to great, great grandchildren) either working behind the bar, taking nominations, prepping and serving food, assisting with the related sports on the day or just a welcoming face to have a yarn.

As history would state, both families moved to the region in the early 1900's and have been here ever since. They have a solid connection with Gregory and the grounds and have been the driving force behind maintaining and developing the grounds and initiating and ensuring continuance of the many events that are held at the Gregory Racetrack each year – Camp draft, Horse sports, Saddles & Paddles, Family Fun Day.

Their commitment to the region (specifically Gregory and Burketown) in Agriculture, Racing, Sports, Provision of Essential Services, Community Events and encouraging community inclusiveness have been passed through the generations and I feel something that should definitely be recognised.

1. PURPOSE

This report provides Council with recommendations to appoint the Principal Contractors to carry out the works designated under 7 individual Contracts for the tendered prices as per Table No. 2 - Recommended Contractors and Prices. With the inter-related nature of the works packages and the tenders received it has been considered appropriate to provide one Council report covering all 7 contracts. It is noted that the overall project budgets for all the projects, excepting Package 4, are provided for under the QRA Restoration Works scheme. This includes preliminaries, consulting services, internal costs, and construction cost for restoration works.

For Package 4 (Doomadgee West Gravel Re-sheeting), allocation from TIDS is combined with QRA Betterment Works funding.

The project budgets' details are provided in Section 4 – Financial and Resource Implications Table 3 & 4.

2. BACKGROUND

As a part of the State Government's Disaster Recovery Funding Arrangements (DRFA) for the 2020 flood events, the following work packages were approved under Restoration Works except for the re-sheeting of 9.35km section of Doomadgee West Road, which is approved for Betterment works which, and is co-funded by DTMR TIDS funds.

There are 4 works packages that have been considered a priority from a programing and scope perspective. These packages were assessed first by the evaluation panel, followed by the final 3 packages. The 4 priority packages are:

- TENDER NO. 0280-4060-1 DOOMADGEE WEST ROAD PART B PACKAGE 4
- TENDER NO. 5606-5000-1 DOOMADGEE WEST ROAD PART A PACKAGE 2
- TENDER NO. 5606-4200-1 NUGABURRA ROAD PACKAGE 5
- TENDER NO. 5606-4250-1 DOOMADGEE LAWN HILL ROAD PACKAGE 3

<u>The tender</u>

The tenders for these projects were released via VendorPanel. The tender submissions received for each project are listed in table 1- Summary of Tender Responses. The tenders submitted by War NQ Pty Ltd are considered non-confirming as they did not provide the mandatory information.

It is noted that GBE are recommended for 4 of the 7 works packages. The evaluation panel conducted a comprehensive review of the submissions, with post tender clarifications also sought to confirm GBE's capacity to carry out the works. In doing so the panel are confident in GBE's capacity to deliver the works for the nominated 4 packages. Taking this factor into consideration was also the overarching reason for not awarding GBE any more than the 4 packages, even though they ranked first in 6 out of the 7 works packages.

4. FINANCIAL & RESOURCE IMPLICATIONS

The budget allocated for each work package and the respective funding from the QRA and TIDS is listed in table 3 & 4. This budget figure incorporates all works to complete the project, including preliminaries, design, project management, contingency, and internal costs.

1. PURPOSE

This report provides Council with a recommendation to appoint Graham Bailey Earthmoving (GBE) for the Gravel Stockpiling Contract No. 5606-5000-2 for the maximum value of \$223,862 (exc GST).

2. BACKGROUND

Stockpiling of gravel at strategically nominated locations is carried out annually to enable the efficient execution of road projects throughout the shire. A Request For Quotation (RFQ) for Gravel Stockpiling (Contract No. 5606-5000-2) was issued to the Burke Shire Council Dozer ROPS on the 1st of February 2021. Responses were required to be submitted by Monday 15th February 2021. Three (3) quotations were received from the following suppliers:

- T's Plants Hire Pty Ltd
- Graham Bailey Earthmoving
- Norwest Consolidated

Following the initial assessment of the quotes, clarification was sort surrounding the transport and survey methodology and the opportunity to revise submitted pricing was provided to all contractors. Final submissions were received on 1st March 2021.

Quotations have been evaluated based on the following criteria:

- Price: 50%
- Capability and Experience: 15%
- Methodology and Program: 25%
- Local Content: 10%

Note that in using the ROPS the tender evaluation is simplified due to the fact that all conforming documentation such as financial capacity, insurances and the like have already been assessed and deemed satisfactory through the ROPS engagement process. Overall capability and capacity has also been covered within the ROPS, with basic clarifications on program requested. Therefore, apart from the Local Content criteria, the evaluation essentially comes down to price, unless there is a significant issue relating to the delivery program.

<u>Tender</u>

Three prices were received, and ranked as follows.

The contractors were evaluated with a summary of the findings below.

<u>GBE</u>

Capability and experience was documented thoroughly in their response. GBE have completed gravel stockpiling for Burke Shire Council on numerous occasions over the last few years including during 2020. The variation between the lower and upper estimated hours to complete gravel stockpiling is relatively low demonstrating confidence in their ability to adhere to estimated hours. On previous occasions where GBE have been engaged for gravel stockpiling works, GBE have not invoiced more than the upper price limit provided. GBE have advised that their D8 Dozer is currently located at their Gregory Depot allowing mobilisation to commence gravel stockpiling as soon as practical (weather dependant).

GBE advised in their submission that two operators will complete the scope of works, working two shifts of 10-12hours. This is to ensure a project program of 8 weeks is achieved. Council will be advising acceptance of the working hours as proposed, should the recommendation be endorsed by Council.

<u>Norwest</u>

Capability and experience was not documented in their response. Norwest has however completed gravel stockpiling for Carpentaria Shire Council on numerous occasions over many years including during 2020. Variation between lower and upper estimated hours to complete gravel stockpiling was low illustrating confidence in their ability to adhere to estimated hours and thus cost.

Norwest have confirmed their availability and adherence to the requested program schedule to complete the works (weather dependent), however a detailed program and methodology of how the works will be completed was not supplied.

T's Plant Hire

Capability and experience was briefly documented in their response. T's Plant Hire has however completed gravel stockpiling throughout Cloncurry Shire and also for Burke Shire Council in the past. Although the response schedule requested a minimum and maximum estimated hours to complete the works, T's Plant Hire provided a single rate / lump sum.
